- 2. Each bid must be completed on SMSD bid forms.
- 3. FREIGHT COSTS MUST BE INCLUDED IN THE BID PRICE(S).
- 4. Alternate bids will be considered only if the alternate properly meets specifications outlined in the bid. (If the bid specifies no substitutes, alternates will not be considered.)
- 5. Cash discounts and delivery will be considered in awarding a contract.
- 6. Deliveries shall be F.O.B. SMSD, stated location, freight prepaid. Title does not transfer to SMSD until received at same.

- 19. In the event that this purchase requires performance of services by Seller's employees, or persons under contract to Seller, to be done on Purchaser's property, the Seller agrees that all such work shall be done as an independent contractor and that the persons doing such work shall not be considered employees of the Purchaser.

AGREEMENT FOR VENDOR PRINTING SERVICES

1. Parties to Agreement

This Agreement for Printing Services ("Agreement") is entered into as of the date indicated below by and between <u>vendor</u>, and **Unified School District No. 512**, Johnson County, State of Kansas (hereinafter referred to as the "SMSD").

2. Services

<u>Vendor</u> agrees to provide all services for printing and mailing three (3) issues of *Inside Shawnee Mission Public Schools* as specified (collectively, the "Publications").

<u>Vendor</u> will print and mail the three (3) issues, respectively, of *Inside Shawnee Mission Public Schools* for the 2021-2022 school year at the following times: Fall 2021 (arrive in mailboxes by no later than November 20, 2021); Spring 2021 (arrive in mailboxes by no later than March 7, 2022); and Summer 2022 (arrive in mailboxes by no later than July 25, 2022).

- 3. Specification for each issue of *Inside Shawnee Mission Public Schools*:
 - (a) Finished size:
 - (i) 16-page "magazine" style publication (up to maximum of 20 pages).
 - (ii) 8.375" X 10.875" trim size"; image area 7.875" x 10.375" with allowance for full bleed throughout the publication (see sample from SMSD purchasing office).
 - (iii) Mailing compliant with not-for-profit postal rate, drop shipping method
 - (b) Quantity: 105,000 copies per printing. This count includes approximately 500 extra copies (to be delivered by vendor to SMSD communications office). After the official mail count has been determined, <u>vendor</u> will deliver all extra copies to the SMSD administrative building at 8200 W. 71st St., Shawnee Mission, KS, 66204, Attn: Communications Department.

4. Terms and Conditions.

- (a) Because SMSD uses a non-profit permit, <u>vendor</u> shall be responsible for taking the publication to the Civic Center Post Office, 550 Nebraska Ave., Kansas City, KS 66101 in order for the mailing to be verified and where the 8125 form will be completed. <u>Vendor</u> shall then deliver the mailing along with the completed form 8125 to all necessary area postal centers serving zip code areas outlined above.
- (b) After <u>vendor</u> has provided SMSD with a postage estimate, SMSD will pre-pay to the post office a portion of such estimated postage (based on weight of 16-pages at the not-for-profit bulk rate) for delivery of the publications to homes. <u>Vendor</u> will contact SMSD to relay the postage rate increase for a 20-page issue (if issue arises).
- (c) Governing Law: This agreement shall be governed by the laws of the State of Kansas. If any provision or provisions of this agreement are found to be void or unenforceable, the remaining provisions of this agreement shall remain binding and in full force and effect.
- (d) This Agreement prohibits <u>vendor</u> from assigning, transferring, conveying, subletting or otherwise disposing of this agreement or any resultant agreement or its rights, title, or interest therein or its power to execute such agreement to any other person, agent, broker, company, insurer or corporation without the previous written approval of SMSD.
- (e) Term of Agreement: The term of this agreement shall be for a period of twelve (12) months commencing on the effective date of this agreement. SMSD retains the right to renew this agreement annually if services are satisfactory and both parties agree.
- (f) Termination of Agreement: Notwithstanding the foregoing, SMSD shall have the right to terminate this agreement at any time immediately upon default of <u>vendor</u> or otherwise upon thirty (30) days prior written notice. In the event SMSD chooses to terminate this agreement, SMSD shall have no further obligations to vendor hereunder.
- (g) Indemnification: Vendor agrees to hold SMSD's Board of Education and SMSD's officials, agencies, and employees harmless from any and all claims, costs or damages, of whatever kind or nature which might be incurred or sustained or which may arise out of or result from the performance of duties and services under this agreement, and shall hereby expressly agree to indemnify the Board, its officials, agencies or employees for any and all costs, claims, loss or damages incurred or sustained by them or which arise out of or result from any acts omissions, errors, representations or misrepresentations, negligence, or

- Terms Herein Controlling Provisions: It is expressly agreed that the terms of each and every provision in this attachment shall prevail and control over the terms of any other conflicting provision in any other document relating to and a part of the contract in which this attachment is incorporated. Any terms that conflict or could be interpreted to conflict with this attachment are nullified.
- 2. <u>Kansas Law and Venue</u>: This contract shall be subject to, governed by, and construed according to the laws of the State of Kansas, and jurisdiction and venue of any suit in connection with this contract shall reside only in courts located in the State of Kansas.
- 3. Termination Due To Lack Of Funding Appropriation: If, in the judgment of the Director of Accounts and Reports, Department of Administration, sufficient funds are not appropriated to continue the function performed in this agreement and for the payment of the charges-hereunder, State may terminate this agreement at the end of its current fiscal year. State agrees to give written notice of termination to contractor at least 30 days prior to the end of its current fiscal year, and shall give such notice for a greater period prior to the end of such fiscal year as may be provided in this contract, except that such notice shall not be required prior to 90 days before the end of such fiscal year. Contractor shall have the right, at the end of such fiscal year, to take possession of any equipment provided State under the contract. State will pay to the contractor all regular contractual payments incurred through the end of such fiscal year, plus contractual charges incidental to the return of any such equipment. Upon termination of the agreement by State, title to any such equipment shall revert to contractor at the end of the State's current fiscal year. The termination of the contract pursuant to this paragraph shall not cause any penalty to be charged to the agency or the contractor.
- 4. <u>Disclaimer Of Liability</u>: No provision of this contract will be given effect that attempts to require the State of Kansas or its agencies to defend, hold harmless, or indemnify any contractor or third party for any acts or omissions. The liability of the State of Kansas is defined under the Kansas Tort Claims Act (K.S.A. 75-6101 et seq.).
- 5. Anti-Discrimination Clause: The contractor agrees: (a) to comply with the Kansas Act Against Discrimination (K.S.A. 44-1001 et seq.) and the Kansas Age Discrimination in Employment Act (K.S.A. 44-1111 et seq.) and the applicable provisions of the Americans With Disabilities Act (42 U.S.C. 12101 et seq.) (ADA) and to not discriminate against any person because of race, religion, color, sex, disability, national origin or ancestry, or age in the admission or access to, or treatment or employment in, its programs or activities; (b) to include in all solicitations or advertisements for employees, the phrase "equal opportunity employer"; (c) to comply with the reporting requirements set out at K.S.A. 44-1031 and K.S.A. 44-1116; (d) to include those provisions in every subcontract or purchase order so that they are binding upon such subcontractor or vendor; (e) that a failure to comply with the reporting requirements of (c) above or if the contractor is found guilty of any violation of such acts by the Kansas Human Rights Commission, such violation shall constitute a breach of contract and the contract may be cancelled, terminated or suspended, in whole or in part, by the contracting state agency or the Kansas Department of Administration; (f) if it is determined that the contractor has violated applicable provisions of ADA, such violation shall constitute a breach of contract and the contract may be cancelled, terminated or suspended, in whole or in part, by the contracting state agency or the Kansas Department of Administration.

Contractor agrees to comply with all applicable state and federal anti-discrimination laws.

- 8. Representative's Authority To Contract: By signing this contract, the representative of the contractor thereby represents that such person is duly authorized by the contractor to execute this contract on behalf of the contractor and that the contractor agrees to be bound by the provisions thereof.
- 9. Responsibility For Taxes: The State of Kansas and its agencies shall not be responsible for, nor indemnify a contractor for, any federal, state or local taxes which may be imposed or levied upon the subject matter of this contract.
- 10. Insurance: The State of Kansas and its agencies shall not be required to purchase any insurance against loss or damage to property or any other subject matter relating to this contract, nor shall this contract require them to establish a "self-insurance" fund to protect against any such loss or damage. Subject to the provisions of the Kansas Tort Claims Act (K.S.A. 75-6101 et seq.), the contractor shall bear the risk of any loss or damage to any property in which the contractor holds title.
- 11. <u>Information</u>: No provision of this contract shall be construed as limiting the Legislative Division of Post Audit from having access to information pursuant to K.S.A. 46-1101 et seq.
- 12. <u>The Eleventh Amendment</u>: "The Eleventh Amendment is an inherent and incumbent protection with the State of Kansas and need not be reserved, but prudence requires the State to reiterate that nothing related to this contract shall be deemed a waiver of the Eleventh Amendment."
- 13. Campaign Contributions / Lobbying: Funds provided through a grant award or contract shall not be given or received in exchange for the making of a campaign contribution. No part of the funds provided through this contract shall be used to influence or attempt to influence an officer or employee of any State of Kansas agency or a member of the Legislature regarding any pending legislation or the awarding, extension, continuation, renewal, amendment or modification of any government contract, grant, loan, or cooperative agreement.
